Property information

We thank you for the opportunity to provide a quote regarding rectification works at the above address.

The above quotation is based on the provided information below:

- The property contains a single-storey brick veneer dwelling on a strip footing with internal concrete stumps.
- The on-site inspection noted stepladder cracks on the Eastern and Western walls.
- The property owner has reported that a flood event occurred on the premises, resulting in water pooling against the Northwestern corner of the structure. Furthermore, it was found that the stormwater system in the Southwestern corner was improperly installed, leading to water saturation in the soil. As a consequence, heave has developed on the strip footing and internal stumps. To address these issues, immediate repairs are necessary, followed by a proper drying process. It is important to note that subsidence may occur after the completion of the repairs.
- Injection will be required along the Eastern, Northern and Western walls. Refer to the site plan for further information.
- The use of an Acrow Prop would be required to assist in the realignment of the Northwestern corner.
- Upon completion of the works, patching to the render in the treatment area will be required.
- Considering the location of the stormwater/sewer pipes, it is strongly advised to use Live CCTV (Closed-Circuit Television) for inspection and monitoring purposes.
- Property Drawing attached.

Injection of Rectify's 2-part polyurethane resins which, after being injected in the required areas, rapidly expands, and fills all voids. This method strengthens the soil and surrounding area ensuring that the above structure is secure, and the likelihood of future subsidence is removed. Once a solid base has been provided, more resin will be injected below as required to achieve lift. Rectify cannot guarantee 100% lift/closure of cracks but all attempts will be made to achieve the best results.

What we provide

- Mobilisation/Demobilisation and establishment at property.
- Identify existing levels and ascertain required work zones and lift required as shown on marked up site plan.
- Appropriate resin selection to achieve the ideal results.
- Removal of all rubbish/materials upon completion of works.
- Rectify's conditional 10-year warranty on materials used.

Client Responsibilities

- Clear work site of any debris/loose material before arrival of contractors, including overlays, floor coverings, furniture, appliances and clearing of any/all debris within the cracks.
- Provide suitable access and parking for Rectify's 10m long (4m high) work vehicle within a maximum distance of 60m from the farthest point of work without any vehicular traffic over our hoses.
- Access to all areas of the property as required from beginning to conclusion of our works.
- If internal injection in required through the sub-floor, Client is to organise access through the flooring via minimum 400mm x 400mm cut outs. These areas are to be confirmed with the Rectify technicians before any works are to begin.
- Continual maintenance of the Property and surrounding areas to prevent further damage due to external sources, including tree roots, broken or leaking services, drainage or other causes that can cause variations in soil moisture conditions.
- Please note that the precautions you should take to protect and maintain the Property including those recommended in/by:

- All making good/adjustments to tiling, flooring and internal/external walls and all making good/replacement of any partially lifted paving on completion of the Services if required.
- Rectify recommends that upon completion of works, where injection occurs near any/all services, inspection should be carried out by an
 appropriate, licensed tradesman (organised by you). If pipes are determined to have been infiltrated by Rectify' s resin material, this can
 be removed by tools such as an electric eel. Rectify recommends after clearing of pipes (if infiltration has occurred), pipes are pressure
 tested for any breaks/cracks (at cost to owner).
- Arranging access from neighbouring property if Acrow Prop is and when required.

Completion Criteria

Rectify Group Pty Ltd shall have fulfilled its obligations when any one of the following first occurs:

- Rectify accomplishes the activities described within this Agreement, including delivery to Client of the completed works noted in the section entitled "Property Information", and Client accepts such activities without unreasonable objections.
- Rectify accomplishes full stability of area of works with technicians on-site determining that any future injection could cause damage to the structure. This will be discussed with the Client and an agreement obtained between both parties that the works are complete. Rectify will monitor the structure closely to ensure that any/all results are documented and provided to the Client upon request.
- Rectify and/or Client has the right to cancel services or deliverables not yet provided with 20 business days advance written notice to the other party.


